We're looking for a visionary leader with strong technical expertise and a collaborative mindset, who can inspire teams, manage key technology partnerships and help us harness technology to serve our audiences in new and engaging ways.

- Manage the selection, implementation and maintenance of technology infrastructure and software, including real-time technologies and virtual production workflows whilst staying abreast of industry trends and emerging technologies, identifying opportunities for innovation and improvement.
- Oversee all technical aspects of broadcast operations, including transmission and playout, infrastructure, and contribution and distribution networks.
- Drive digital transformation across platforms ensuring a seamless, innovative viewer experience across broadcast, online, and on-demand services.
- Lead on the development and maintenance of a resilient, secure, and scalable technology architecture.
- Champion innovation in areas such as AI, automation and data analytics.
- Oversee S4C's IT and cyber security strategy and lead on replacement of S4C's broadcast management system, ensuring compliance and protection of systems and data and suitability for S4C's multi-platform strategy.





- Build strong relationships with internal teams and external partners including production companies and suppliers and manage contractual relationships with suppliers of outsourced technology services.
- Lead, inspire and develop high-performing technology teams with a focus on culture, diversity, and continuous improvement.
- Manage budgets, risk, procurement, and lifecycle planning for all technical systems and capital investment projects.
- Ensure compliance with all relevant broadcasting, digital, and data regulations (e.g., Ofcom, GDPR).
- Provide strategic input at Board and Executive level, acting as a key advisor on all technology-related matters, and represent S4C in industry-wide forums on future developments in television.
